# Independent Order of Odd Fellows of Maine

## By-Laws

### Joint Planning Board

Revised 16 January 2021

.The purpose of this Joint Planning Board is to propose and develop Projects to benefit all Grand Bodies and the Membership.

#### BY-LAWS

##### Article 1:

Section I, MEMBERSHIP- Each Grand Body shall name (elect or appoint) a Planning Board committee of Elective Officers and members, yearly.

Section II, FUNCTION: - Such Board Shall have official status and shall function as a Board.

##### Article II

Section I. MEETINGS: - Joint Planning Board may meet two times per year. Once in January and once in September. Place and date of the meeting to be determined by the Board.

Section II, HOUR AND PLACE OF MEETING – The Joint Planning Board Shall meet at an hour and location to be determined by the Board. This meeting is open to all members in good standing. Dates and times will be published.

Section III, ANNUAL MEETING – The Annual meeting of the Joint Planning Board will be held at the meeting in September.

##### Article III

Section I, OFFICERS – The Board shall elect its Chairperson, Vice Chairperson, Secretary-Treasurer from its membership. The Vice Chairperson to be elected from the next Branch of the order at the annual Session. (Grand Lodge, Rebekah Assembly and the Grand Encampment) This is to be on a rotation basis from all Branches of the Order. The Secretary-Treasurer may serve more than one year in that office.

Section II, DUTIES – Recording meetings and make a report to each Branch of the Order, annually, at its Session that its Programs shall be supported by all Branches of the Order.

The Secretary-Treasurer to receive and disburse any monies and take minutes of the meetings.

##### Article IV

Section I, FUNDING – All Grand Bodies shall be required to participate and grand Bodies may appropriate funds for expenses from the Board.

##### Article V

Section I, COMMITTEES – Committees, as may be required, shall be appointed by the Chairperson.
